Llanwrtyd Wells Community Transport (LWCT)Ltd: and Events Recycling

As we celebrate the 20th anniversary of this voluntary 'not for profit' organisation, we thought it might be useful for you to learn something about the services we provide and how we've changed over the years to be the successful group we are today

We provide the collection and delivery of shopping, prescriptions, and pre ordered take away food for vulnerable members of our local communities thanks to our wonderful Volunteer Drivers. We also provide a service to residents needing to attend medical appointments both near and far, and currently some of our journeys can be provided free of charge due to some grants we have received and are extremely grateful for. We have a wheelchair accessible vehicle for members who cannot access an ordinary vehicle.

We have a Shopping Bus Service where members email or phone in their order and we can collect several people's order at the same time, using local supermarkets and local shops. The driver and assistant then sort and deliver the goods to individuals.

We provide mini bus hire, with or without a driver, so if you are taking a party

somewhere please enquire about prices for hire.

We arrange outings to somewhere of interest during the summer months, and most recently have visited Myddfai Farmers Market, Ystrad Nurseries and the Alpacas, The Thomas



Shop at Pennybont, Three Cocks Garden Centre etc.



To become selffunding, the company branched out and registered as a

professional dealer/broker of controlled waste. It has been responsible for providing waste management and recycling at



most of the events at the Royal Welsh Showground including Wonderwool, Smallholding Festival and the Winter Fair to name but a few, also smaller local events and celebrations. We can provide this service for your local carnival, street party or fête.

We work closely with Powys County Council to provide some of the transport for students to attend school including students with special needs. These are essential roles as they help to subsidise our other transport services.

The initial aim of the project, that became operational in 2002, was to provide transport for all age groups, because public transport is somewhat limited in this area.




In mid-2020 we had the opportunity of renting the Lion Yard in Builth Wells. These are super premises big enough to house our vehicles, provide garage space for repairs and maintenance, a place to store all our recycling bins, and office space.

Coupled with the beginning of the Covid-19 virus and the restrictions on movement that were operational at that time, as you might imagine, the move was a mammoth task, but well worth it.

'After 15 years working with a breakdown and recovery firm, I started with LWCT as a driver/escort for an ALN school run in October 2011. I started doing some part-time admin



I was asked to become a Company Director, a position I was pleased to accept. I believe the services provided by LWCT are so essential in this area and the organisation does its job

well. I am currently helping to develop a Welsh-language Action Plan.

I have moved around the UK, being born in Yorkshire, lived in Buckinghamshire, Kent, Leicestershire, and finally moving to Llanwrtyd Wells for the peace and the beauty. Fortunately, I was able to retire early, although I still run my own business partnership part-time.
